Accessing and downloading your TDS Certificate for Dividend paid for FY 2023-24

This has reference to the payment of final Dividend at the rate of Rs.6.30/- per share (315%) on equity shares of the face value of Rs. 2/- each, made by Mahindra & Mahindra Financial Services Limited ("the Company") for FY 2023-24, in July 2024. Pursuant to and in compliance with the provisions of Income-Tax Act, 1961, as amended by the Finance Act 2020, tax was deducted at source from the said Dividend amount at the prescribed rates inclusive of applicable surcharge and cess, based on the information received by the Registrar and Transfer Agent/ Company, from the Depositories and the Shareholders. The tax deducted on dividend has been paid to the Central Government and necessary return has been filed with the Tax authorities as required.

You can view the credit of Tax Deducted at Source ("TDS") amount in your Form 26AS which can be downloaded from your e-filing account at <https://eportal.incometax.gov.in/iec/foervices/#/login>.
